# Workers refute accusations of Chinese factory owner

CHINESE factory workers refuted Chinese media reports, saving incorrect information was disseminated over the dispute between them and the factory owner.

At a press conference in Yangon yesterday, representatives of the workers denied the accusations mentioned by the Chinese Xinhua News Agency and China Daily and accused the employer of the Yangon factory of providing incorrect information to Chinese diplomats in Yangon that included details of a destructive 23-24 February attack at the factory. The Chinese embassy issued a paper that was carried by Xinhua News agency and China Daily that alleged the workers "stole personal belongings," of Chinese staff, strikers said.

The Chinese embassy in Myanmar has lodged a protest with authorities.

Although chairs and a car mirror were destroyed, workers said at the press conference, "We did not destroy any products nor machinery," at which photos of the attack were displayed.

It is believed that the attack on the factory was carried out by hundreds of striking workers angered by the sacking of a colleague last week. The Confederation of Trade Unions of Myanmar arranged the press conference for the workers because they have the right of reply, said U Maung Maung, Chairman of the CTUM.

"We have the law to settle the dispute between the employers and employees and tribunal bodies. Time and space should be given first to tribunal bodies instead of lodging a complaint to the Union Government through diplomatic channels," said U Maung Maung.—GNLM

# Int'l community urged to take more positive approach to help resolve rights issues

MINISTER of State for Foreign Affairs U Kyaw Tin attended the High-level Segment of the 34th Session of the Human Rights Council, held in Geneva from 27 February to 1 March 2017, and delivered a statement on 28 February 2017. In his statement, U Kyaw Tin underscored that the Human Rights Council should be promoting and protecting of the rights of all peoples in a manner of impartiality and the interest of all states. Any deviation from such inclusive, equal, and non-discriminatory approach will affect the confidence in the work of the Council by the member states of the United Nations. He also apprised the Council on matters pertaining to the Government's new approach of engagement and cooperation on the promotion of protection of human rights, the Government's priorities, peace process, the Government's effort for finding sustainable solu-

tion of the issue of Rakhine State including establishment of domestic mechanisms. He also pointed out that at a time when the Government's such efforts were gaining momentum, the coordinated armed attacks against three police outpost took place in northern Rakhine State on 9 October 2016. He briefed the Council of such attacks. conduct of area clearance operation to arrest the perpetrators and to retreat arms and ammunition taken away by the armed attackers and ongoing investigation through a national investigation commission on allegations of human rights abuses. The Minister of State also stressed that any action by the HRC must be a cure and part of the solution, not part of the problem; the Council's focus must be on resolving, not inflaming, the very evident tensions in the Rakhine State and on helping us bring the

communities together instead of

driving them further apart. He also asked the international community to take a more positive approach to help resolve the issues, rather than focusing on condemnation, punishment and resentment.

On the sidelines of the High-level Segment, the Minister of State met with Mr. Alok Shama, Parliamentary Under-Secretary of State at the Foreign and Commonwealth Office of the United Kingdom, Mr. Stavros Lambrinidis, Special Representative on Human Rights of the European Union, Mr. Scott Busby, Deputy Assistant Secretary, Bureau of Democracy, Human Rights and Labour of the United States Department of State, and Ms. Marit Berger Rosland, Deputy Minister of Foreign Affairs of Norway separately. During the meetings, they exchanged views on matters relating to the national reconciliation and peace process in Myanmar, development in Rakhine State and sustainable solution of the issue in Rakhine State, promotion and protection of human rights, understanding and cooperation extended to Myanmar while discussing the human rights situation in Myanmar in the Human Rights Council.

The Minister of State attended the working lunch hosted by

the Permanent Representative of Indonesia to the United Nations in New York, on 27 February 2017 in Geneva. During the working lunch, the Minister of State briefed them on the Myanmar Government's utmost efforts for peace and reconciliation and for development of the Rakhine State and sustainable resolution of the issue. U Htin Lvnn, Permanent Representative/ Ambassador of Myanmar to the United Nations in Geneva also accompanied the Minster of State for Foreign Affairs at the abovementioned meetings.
